Resolution to Establish Regular Meetings of the Charlottesville-Albemarle Regional Transit Authority

WHEREAS, the 2009 S 33.2-2800 of the Code of Virginia Title 33.2 created a political subdivision of the Commonwealth known as the Charlottesville-Albemarle Regional Transit Authority; and

WHEREAS, In January 2025, the City of Charlottesville and Albemarle County enacted the Charlottesville-Albemarle Regional Transit Authority; and

WHEREAS, the Charlottesville-Albemarle Regional Transit Authority's bylaws state that regular meetings of the Charlottesville-Albemarle Regional Transit Authority Board will be held on a periodic basis as determined by resolution of the Charlottesville-Albemarle Regional Transit Authority Board, but not less frequently than once per quarter at a place to be determined by the Chair, or at such time and place as the Charlottesville-Albemarle Regional Transit Authority Board may determine.

NOW, THEREFORE, BE IT RESOLVED, by the Charlottesville-Albemarle Regional Transit Authority Board as follows:

- 1) That this Board will hold its regular meetings on the fourth Thursday every other month starting in May 2025. Regular meetings will begin at 5:00 p.m. at the Thomas Jefferson Planning District Commission meeting space located at 401 or 407 East Water Street, Charlottesville, VA 22902, or as otherwise posted.
- 2) All Authority Board meetings will be open to the public in accordance with the Virginia Freedom of Information Act (Virginia Code §2.2-3700 et seq.), provided that the Authority Board may meet in closed session for those purposes authorized by and held in accordance with the requirements of the Virginia Freedom of Information Act.
- 3) All meetings of the Authority Board will be preceded by public notice given in accordance with the provisions of the Virginia Freedom of Information Act (*Virginia Code § 2.2-3707 et seq.*). Notice of all meetings will be published on the TJPDC website.
- 4) That this resolution shall become effective upon adoption.
